This DECLARATION OF TRUST is made this the
twentysixth day of February one thousand nine hundred
and seventyfive by Shri K. Hanumanthaia, Member of Parliament,
Kengal Krupa, Sadashivanagar, Bangalore-6 hereinafter
referred to as the SETTLOR.

WHEREAS with the object of perpetuating the memory
of Freedom Fighters (that is persons who fought for the
liberation of India and the establishment of a democratic
system of Government) the Settlor and few of his friends
decided that a memorial building for the purpose may be
constructed in the Lal Bangh, Bangalore City, to be named
VEERA SOUDHA and the Settlor has collected public donations
to the tune of Rs.15,000/- (Rupees fifteen thousand only)
and kept in deposit;

WHEREAS the Settlor and his said friends decided that
a Trust be created for dealing with the said sum and also
sums of moneys to be collected hereafter for the purpose (and)

and for taking all necessary action in the matter of the construction of Veera Soudha;

NOW, THEREFORE, in pursuance of the aforesaid, the Settlor hereby declares and constitutes, subject to the terms and conditions hereinafter detailed, a Trust and transfers the said sum of Rs.15,000/- (Rupees Fifteen thousand only) to the said Trust to be held in Trust as Trust Fund for the purposes of the Trust:-

(1) The Trust shall be known as VEERA SOUDHA TRUST, Bangalore.

(2) The following shall be the First Trustees, namely:-

- (i) Shri K.Hanumanthaiya
- (ii) Shri D.Devaraj Urs, Chief Minister, Karnataka,
- (iii) Shri H.M.Channabasappa, Minister for Public Works, Karnataka. (q)

Shri K.Hanumanthaiya shall be the Chairman of the Board of Trustees.

(3) Any vacancy in the office of the Trust, either by resignation of a Trustee or otherwise shall be filled by the remaining Trustees, co-opting another person as Trustee.

(4) The Trustees, all of them, may co-opt one or more persons as Trustee or Trustees along with them.

(5) The main object of the Trust is to construct the Veera Soudha in Lal Baugh, Bangalore City, to perpetuate the memory of the Freedom Fighters (referred to as aforesaid).

It shall, however, be open to the Trustees to pursue objects incidental or ancillary thereto.

(6) All contributions and donations received by the Trustees for the purpose of the Trust from whomsoever shall form part of the Trust fund. This shall be initially applied by the Trustees for the construction of the Veera Soudha, any balance remaining over shall be applied for such purposes incidental or ancillary to the objects of the Trust.

(7) The Trustees shall take action for the collection of Trust funds and for the construction of the Veera Soudha.

(8) The Trust fund shall be kept in deposit in a Scheduled Bank to be decided by the Trust in the name of the Trust and shall be operated by the Trustee to be appointed by the Trust.



(9) The Trustees shall maintain true and correct accounts of all moneys received and all moneys expended by the Trust.

They shall get the accounts audited by a qualified auditor.

(10) The Veera Soudha to be constructed shall be the Trust Property. After its completion the Trustees may hand it over to the State Government for management on such terms and conditions as the Trustees may consider best consistent with the objects of the Trust.

(11) Any other property, movable or immovable, acquired or constructed out of the Trust funds shall also be Trust Property to be used for purposes of the Trust or purposes incidental or ancillary to the same.

(12) The Trustees may frame rules to regulate the procedure to be followed by them with regard to meetings etc., connected with the Trust.

(13) Quorum for any meeting of the Trust shall be three. Decisions shall be taken by majority votes. In the case of equality of votes, the Chairman or the person presiding at the meeting shall have a second or casting vote.

(14) The Trustees may appoint such staff, Advisory Committees and Consultants considered necessary for carrying out the objects of the Trust and expenditure therefor shall be borne from the Trust fund.

(15) The first Trustees accept the appointment as Trustees and in token have affixed their signatures hereunder.
